### WEDGE ISLAND EVENT 19 TO 23 FEB 2025

THIS EVENT WAS ATTENDED BY DAVID VEENSTRA, ERIC TREVASKIS, BARRY CARSON, DICK JONES AND IAN GOODALL

ON THE 18TH DAVID GOT UP THERE EARLY TO SET UP, ERIC AND MYSELF ARRIVED ON THE 19TH, DAVID HAD FOUND THAT THE BORE WAS NOT PUMPING SO I LOADED SEVERAL CONTAINERS ONTO THE BACK OF MY VEHICLE AND WENT TO CERVANTES AND LOADED UP WITH 190LITRES OF WATER FOR USE IN TOILET AND SHOWER.

## **General Sir Harry Chauvel**

In the afternoon of 4th March 1945, the death occurred in Melbourne of General Sir Henry Gordon Chauvel, better known to many Australians as General Harry Chauvel. Harry Chauvel was well known to many Australians after WW1 due to his leadership of Light Horse units, first on Gallipoli and later in the Middle East where he eventually became commander of the Desert Mounted Corps. As a military leader Chauvel was resolute, cool in tight situations but flexible in his decision making. As Henry Gullett the official WW1 historian relates:

He fought to win, but not at any price. He sought victory on his own terms. He always retained, even in heated moments of battle, when leaders are often careless of life, a very rare concern for the lives of his men and his horses.



Soon after WW1 he was appointed Chief of the General Staff, and remained in this position of influence until 1930.

This brief article is not to elaborate further on his WW1 military achievements, but to view aspects of his upbringing and civilian involvements after the war, as well as comment on his relationship to 10th Light Horse.

Following his retirement from the army in 1930 Harry Chauvel immersed himself in a multitude of civic, commercial and religious affairs. Amongst such undertakings, he became a director in several prominent commercial enterprises including the National Bank, and the Colonial Mutual Life Assurance Society, as well as chairman of the Australian board of the General Accident, Fire and Life Assurance Corporation. He was also appointed chairman of the National War Memorial in Canberra, and remained in that appointment until his death. He was also active in the Anglican church. Sir Harry had been raised in a family of Huguenot descent, with strong protestant orientations, and in colonial Sydney his family had made substantial financial and individual contributions to the formation of the Anglican diocese of Grafton and Armidale. As a young man Harry attended Sydney Grammar School where religious education enhanced his personal beliefs. The effects of his religious beliefs are not readily visible in most accounts of his military achievements, but it is not unlikely the calmness under duress often referred to by many of his military biographers was tempered by his firm religious beliefs. During his post WW1 period as Inspector General of Australian forces, he and his family moved to Melbourne, and following his retirement from the army Sir Harry served as a member of the Anglican Synod, for many years representing Christ Church South Yarra. He also became a lay canon of St Paul's Cathedral for the period 1930-1933, and held the stall named for Richard Hooker, an honorary appointment involving responsibilities for developing and enhancing Anglican Church life.

As well as these endeavours, Sir Harry continued to take part in military activities. He was continually invited to army functions, dinners and parades, especially Anzac Day parades, at which he often either took the salute or led in person. He wrote newspapers articles and took part in radio broadcasts, often commenting on the need for support of retuned soldiers. In commenting about his eligibility to lead an Anzac parade in Melbourne in April 1935, one newspaper correspondent commented that through his quiet work in the interests of returned servicemen he had come to be regarded as their peace-time leader. In December 1936 he led the Australian contingent to the coronation of George VI in London, and at his insistence the uniform worn by the Australians included most of the accoutrement of the Australian Light Horse including a slouch hat, emu plumes and spurs.

With the advent of WW2, a volunteer defence corps (VDC) comprised mainly of armed civilians was formed to complement AIF and militia forces defend-

ing mainland Australia. Sir Harry Chauvel was invited to act as Inspector-in-Chief of the nascent corps, an invitation he accepted. Is not unlikely that his acceptance of the appointment influenced the decisions of thousands of former WW1 AIF soldiers who joined the new corps. His activities in the VDC involved constant travels to inspect units throughout Australia, duties which eventually started to wear down the veteran soldier, now aged in his late 70's. When at home in Melbourne Sir Harry was in the habit each morning of riding along Alexandra St near the Yarra River, but in 1944 a recurring knee injury forced him to give up his riding. Early in 1945 his condition deteriorated to such an extent that he was committed to hospital, where he died. Sir Harry never lived to see the WW2 victory to which he had contributed, both directly and indirectly.

In July 1952 a commemorative plaque, designed by the Australian ecclesiastical architect L.R. Williams, in remembrance of Sir Harry was placed in the North Aisle of St Paul's Cathedral, Melbourne, and dedicated by incumbent church dignitaries.

In 1923 Sir Harry was offered and accepted an appointment as Honorary Colonel of 10th Light Horse, about which he is reported as having said: ... there was no other regiment in Australia or in any other country, of which he would sooner be honorary colonel. He was re-appointed to that position in November 1928, and again in July 1933. From then no further notifications regarding Sir Harry's appointment to 10th Light Horse appear in the Commonwealth Government Gazette. The spacing of the original re-appointments suggest that five years was considered the tenure of an Honorary Colonel, and by this measure his reappointment as Honorary Colonel, or his relinquishing of the position, would have been expected at some time during 1938 -- but no such notice appears. A newspaper article notifying the funeral arrangements for the notable West Australian soldier, Sir Talbot Hobbs in May 1938 include a statement that Sir Harry, as Honorary Colonel represented 10th Light Horse at the funeral. Accordingly, in the absence of any further notifications, the possibility exists that Sir Harry remained Honorary Colonel of 10th Light Horse up until the time the Regiment was disbanded in May 1944, and in theory remained as Honorary Colonel, even after his death, until the appointment, in 1952, of the then Governor of Western Australia, Lt Gen Sir Charles Gairdner as the first Honorary Colonel of the resurrected regiment.
