# LIFE MEMBERSHIP OF RAACA WA INC. - MR JOHN SANDERSON

Mr John Sanderson served in Vietnam with 1st Armoured Regiment, his troop engaged in many operations and is mentioned a couple of times in the book "Cannister On Fire", detailed coverage of that unit's participation in that conflict. He served in 10LH Regiment on ARA staff for a number of years as well as OC Irwin Barracks rising to the rank of MAJOR with his final posting QM at RMC Duntroon.

He was a member of the Association during and after he retirement settling in Perth where he spent many years volunteering as an Advocate for past serving members working with a group located at Leuwin Base.

John was both State and National Vice President 2004 to 2007 of the Association and during that time where contacts made during his ARA service were used to the benefit of our members. Apart from normal leadership responsibilities he was a major contributor to a number of projects here in the West.

The first was the working towards the establishment of our own accommodation, at the time the committee used the old officers mess for meetings. His knowledge and contacts with current ARA and Defence Force people in the West contributed in no small way to the obtaining a lease of an old married quarter at Irwin Barracks. The lease was granted on the basis of membership support, welfare and advocacy services.

The second was working with President Terry Stidwell (RIP) in developing a business case for the establishment of Advocacy and Welfare services for both members and other ex-service men and women. Funds and support from DVA were also sought and achieved to purchase office and furniture for the house and ongoing administrative costs. Once again, his knowledge and contact system came into play.

John headed up the Advocacy and Welfare unit within the Association continuing to provide his expertise in helping out ex-service people within the Association, fellow members in other Staes and ex-service people approaching us for help. At that time problems facing Vietnam Veterans who were getting older were surfacing and we were handling quite a number of cases along with ARES people who had sustained injury and/or qualified for DVA support. That service sourced DVA funding for a few years for administrative costs and then and continued as a service to this day for Association members through John.

John also initiated the Bunnings fund raising program. It took some convincing that we were eligible to participate in the Bunnings program but with the help of many over the years it became our major fund-raising event.

John continued in the position of Vice President for a number of years with his major focus providing expert advice and the Advocacy and Welfare area for Association and other ex-serving members of the Corps where required.

His membership of the Association well exceeds thirty years plus.

In 2005 the committee sought accommodation that was more fit for purpose to provide advocacy and welfare services for our members and the wider Corps past serving members, administrative and social centre for our members and as it turned out be located on the base where the Corps is represented here in the West the 10th Light Horse Regiment.

The old married quarter was in a sad state of dis-repair and required months of voluntary work by members of the Association to bring it up to a habitable standard. Office and meeting room furniture and equipment was obtained through a DVA grant or donated. Lease arrangements have been in place since that time with Defence.

Working bee days have kept the establishment up to scratch over the years and for some years now ground and house upkeep has been the province of our Vice President Colin Davies who has generously supported that activity — the most recent donation being an electric, self propelled mower. President Barry also contributes generously with his time in that activity.

Thank you to those who have made donations towards the upkeep of the house, your contributions are appreciated.

The house also caters for the storage and display of memorabilia, art and Association records including Commentary (since 1945). It also has an extensive library of Australian military history.

If you are interested in visiting the house and viewing all the contents please ring our Secretary Ian and come down when we have a committee meeting or other meetings at the house.
